

FACT SHEET

WHAT

Coos County Area Transit is currently in the process of developing a Transit Master Plan to provide strategic guidance to Coos County for the provisions of a sustainable and innovative transit system. The Transit Master Plan will include short-, medium-, and long-term guidance on providing transit services, bus stops and facilities, and coordination with transit services within the County such as Curry County's Coastal Express and Pacific Crest Bus Lines. In addition. the Transit Master Plan will examine how existing urban and outlying rural services can be improved and better coordinated to need the needs of the region.

WHY

Coos County Area Transit completed a Coordinated Transit Plan in 2016 to include area health service providers. However, a Transit Master Plan is needed to includ economic interests. tribes, schools, and other community stakeholders. The development and completion of a Transit Master Plan is a critical step in securing Statewide Transportation Improvement Funds that may be used for public transportation purposes that support the effective planning, deployment, operation, and administration of public transportation programs. The objectives of the Coos County Transit Master Plan are to provide broader regional connectivity, clarify criteria for future service mortification, establish a goal-based framework to identify transit needs and improvement options, explore alternatives to address transit needs, identify potential funding sources, and identify connection efficiencies.
